## AN INITIATIVE PETITION

### FOR A CONSTITUTIONAL AMENDMENT

Under Article XLVIII of the Amendments to the Constitution of the Commonwealth

### SUMMARY

This proposed constitutional amendment would reduce the minimum voting age from eighteen to sixteen years of age.

**FILING DEADLINES.** Initiative petitions must be submitted to local election officials for certification of signatures no later than **5 p.m. on Wednesday, November 21, 2007**. Local election officials must complete their certification no later than December 3, 2007. Thereafter, initiative petitions containing certified signatures must be retrieved by petitioners from the local election officials and then filed with the Elections Division, Office of the Secretary of the Commonwealth, One Ashburton Place, Room 1705, Boston, MA, no later than **5 p.m. on Wednesday, December 5, 2007**.
